1. Confirmation of Minutes:

4. R & D Report:

The Director elaborated the highlights of the R&D work to the Council for the quarter October to December 2023.

Mr P C Dhandania Chairman Engineering & Manufacturing Committee informed the activities of the TPMA department. He informed that Mr Sanyal retired and the activities have been given to Dr A Hazarika. He also informed about the lateral flow rapid test equipment for pesticides testing by China.

Mr Rajvinder Singh highlighted the need for addition of new chemicals with MRL's. The existing list of chemicals are limited and sometime resistant to pests. It was informed that TRA has written to the Agriculture Ministry for clearance for 7 new compounds.

7. To discuss on the arrangement of Bicentenary Assam Tea International Conference BATIC 2024 & the 25th session of FAO IGG on Tea.

The Association is organising the 200th year of Assam tea in collaboration with Department of Commerce, Government of India, Government of Assam and Tea Board of India. The budget for the BATIC 2024 and the FAO IGG is enclosed as Annexure 2. The Secretary TRA elaborated on the up to date status alongwith the budget for both the events. The Council noted the same and approved the budget.

8. Appointment of Trustee for The Tea Research Association Provident fund Trust

The Council resolved to appoint Ms Nayantara Palchoudhuri, Chairperson, TRA and Mr Atul Asthana, Vice -Chairman, TRA as Trustee of The Tea Research Association Provident Fund in place of outgoing Trustee Mr. D.P. Maheshwari and Mr. J S Kandal.

Further, both the new Trustees will be the signatories of the current bank account no. 38067257288 of the PF Trust maintained with SBI, N.S Road Branch in place of Mr. D.P. Maheshwari and Mr. J.S Kandal.

9. Any Other Business:

- a) Partnership with Tridge South Korea on profit sharing basis was discussed and approved.
- b) Chairperson informed on the new MOU's signed.
- c) The Council approved the removal of the name of Mr B.J.Chakraborty, Administrative Controller from all existing bank account of Tocklai, Jorhat. Further, Mr Jayanta Sharma, Accounts Officer, TTRI, was included as signatory for Kotak Mahindra Bank.
- d) The Council resolved to open a new project bank account in Union Bank of India, Jorhat Branch in the name of DST- Camellia-IDrone. This project is funded by DST through PFMS.
